-Guidelines-

- 2. The video recording duration must be a minimum of one (1) minute and a maximum of three (3) minutes.
- 3. Video shall be taken in landscape format.
- 4. Select student leaders will be requested to give permission to the organizing committee to use their photos and testimonials by filling out the Photo and Film Consent Form provided by PSA. Rest assured that the information gathered will be kept confidential.
- 5. Output shall be submitted to the YFD contact person, Mr. Arman Jay B. Dudas, Senior Technical Assistant I, through his email address arman.dudas@deped.gov.ph. These will be forwarded to the partner organization once completely submitted by the student leaders.
- Video shall be submitted on or before 12 April 2021, Wednesday on or before 5:00p.m.
