The Department of Education (DepEd), in coordination with the National Youth Commission (NYC), will conduct the celebration of **National Students' Day (NSD)** on **November 17, 2020**. Pursuant to Republic Act No. 11369 or the *National Students' Act*, DepEd recognizes the observance of November 17 of every year as National Students' Day and a commemoration of International Student's Day, which was spearheaded by the International Students' Council in 1941.

In line with the theme ***Mag-aaral na Pilipino, Palaban sa Buhay Gamit ang Puso, Galing at Talino***, this year's celebration aims to express support and recognize the invaluable contribution of students to education and to generate assistance for students.
